

### Refund and Cancellation Policy

Thank you for joining Life With Tania for the **TRAVEL WITH TANIA FRIENDSGIVING IN ARUBA**. The cost of the Retreat is \$ \_\_\_\_\_. This flat fee includes the following: \_\_\_\_\_ nights of accommodation at the Merlot Villas Aruba; \_\_\_\_\_ group meals per week such as breakfast, brunch, lunch and dinners held together as a whole group; general refreshments, beverages, specific excursions such as a boat trip with an opportunity for snorkeling and an open bar, visiting Arikok National Park, sightseeing at San Nicolas, organized parties at specifically chosen locations for the whole group, transportation to the selected excursions and back and forth from the main airport. Further, as part of the fees, participants will be able to select from a number of Life With Tania promotional material including but not limited to: calendars, live streaming tickets, and other Life With Tania materials. \_\_\_\_\_.

The Retreat shall offer two experiences: a shared room or an individual room. Neither option is to be considered greater than the other, nor shall either option be promoted more over another. Instead, the shared room or individual room option is presented as a means to offer another meaningful manner for Participant to enjoy the retreat experience.

The Participants who choose to opt for the shared room experience, the deposit shall be \_\_\_\_\_, and the monthly payments shall be \_\_\_\_\_.

At the time of your reservation for the Retreat, the Participant must produce the non-refundable deposit of \$ \_\_\_\_\_ USD (“Deposit”). This Deposit counts toward the total cost of the Retreat, which stated above has a total cost of \$ \_\_\_\_\_ USD.

The payment of the total cost of the shall be paid in six (6) monthly payments of \_\_\_\_\_. The payments shall be paid online at \_\_\_\_\_. Participants can either pay in monthly installments or in total up front. For the monthly installments, each payment shall be made on the 10<sup>th</sup> (tenth) day of the month prior to November 2023 when the trip is scheduled to take place.

Life With Tania shall provide for partial refunds as long as the request is made at the earlier of 90 (ninety) days before the scheduled trip in November. The final date where a request can be made shall be Friday, September 1, 2023. Any request for a refund will not be accepted at any point after September 2, 2023.

Upon a timely request, the partial refund shall be half of what has already been paid, but no more than **half of what the Participant has already paid**. The refund will be paid via \_\_\_\_\_.

If a conflict arises, the reserved party will be able to transfer their reservation to another party. The new party will then have to submit the **\$500.00 USD** deposit. The transferring party will not be afforded a refund as they are not formally requesting a refund, rather they are simply making a reservation transfer and the new reserved party will take place of initial party at the Retreat. In

the event there are still remaining payments to be made, the new party/Participant shall make those payments.

Lastly, if a party is required to cancel, the cancellation should be submitted by the Friday, September 1, 2023 date. Anything beyond that time frame, the party will not receive any refund or return of monies spent toward the payment of the Retreat.

This policy shall be effective from January 1, 2023 and the Participant/reserved party shall be bound by this Policy upon reserving their place with the Retreat.
